District 96 Audit Committee Chair, Phuong (David) Nguyen, shared the findings submitted by the Audit Committee. He concluded that everything is in good standing.

This was the first time leading the Audit Committee through the Mid-Year Audit and we were successful at submitting it on time. Thanks to fellow committee members of Jonathan Buchanan, and Veronica Maynard, for their help and Finance Manager Yolanda Li for her assistance.

Audit Committee Report

The Audit Period was between July-December 2022. For that period we had a Monthly Net Loss of (\$3,303.86) and a Year to date Net Income of \$14,709.68. The total available funds up to then were \$86,389.60.

Revenue by Type, Year to Date as of Dec .31, 2022 All the Revenue is from membership revenue which was \$23,545.11

Expenses by Type, Year to Date as of Dec .31, 2022 As you can see from the chart, most of our expenses came from Club Growth, Admin, and Marketing outside of Toastmasters, and Recognition.

Reimbursement requests have been approved by the district director with adequate documentation.

Payments that are in excess of \$500 USD were properly approved by the district director and an additional member of the district trio. All transactions were authorized in advance with adequate documentation.

There were no Debit Card transactions made during the July-December 2022

Audit Notes:

There is a check of \$58.12 written to UBC TOASTMASTERS dated August 05, 2022, and was manually entered into Intacct. The expense was recorded in the end accruals for Y/E 2022-07-31. Toastmasters International deemed the transaction as voided and adjusted the transaction in Intacct. The check was yet to be deposited and by still be deposited in the current fiscal year.

The reimbursement of \$1,140 in the check registered on July 7, 2022, was for the 2022 April District conference streaming. The reimbursement was submitted on June 30, 2022, and was approved on June 30, 2022. The reimbursement was processed on July 7, 2022. Mark Hurrell emailed Toastmaster international to move the reimbursement to June 30, 2022, on August 8, 2022, and has yet to be completed. With the assistance of Mark Hurrell, the audit team was able to confirm the transaction was approved and had the supporting documentation.

11. DISTRICT DIRECTOR REPORT

District 96 Director, Lily Laverton, DTM shared that we currently have 88 clubs, which is the lowest amount since the District's split from District 21. We also have 687 new members which might make us, currently, first in the region. Lily reviewed the District timeline tasks to show the work done by the team. Lily also went over that we need to work on chartering new clubs to grow the District. Lily brought up that not all club visit reports were submitted since we did not have an Area Director for every Area. Lily reviewed the current club renewal status. She also mentioned that we need more practice hosting hybrid events. The District has also been holding a monthly "Community Connection" event to answer questions about Toastmasters and Pathways. Lily also mentioned the club analytics tool created for the District to learn about club initiatives and challenges. Lily also thanked the leaders who have stepped forward for various roles.

Thanks were extended to the District Director Team for their amazing work.

12. PROGRAM QUALITY DIRECTOR REPORT

Program Quality Director, Michael Gurney, DTM, discussed his work on the second round of club officer training, his encouragement for Area Director Club Visit Reports, as well as getting prepared for June's training events. Michael discussed how club quality is expressed through clubs engaging in targeted outreach (such as sending personal invitations to specific groups or organizing events), utilizing social media, and hosting special events such as workshops and contests. Clubs are becoming more flexible and require us to get regular feedback on how meeting times and formats can best meet their members' needs. 106 clubs have submitted officers' lists (98%). Membership dues for 88 clubs are current (81%). 608 education levels have been completed. 55 members have completed 3+ levels. District is 1300 members strong (-9.3%). 21 clubs are Distinguished (19%). With growth, 39 clubs will become Distinguished. Leader training June 3 - 4. Club quality is driven by positivity and support. Michael recommends attending the upcoming Conference to see Toastmasters in action.

13. CLUB GROWTH DIRECTOR REPORT

Club Growth Director, Paul Rostagno, DTM, began by saying that growth takes time and patience and that it is now the time to bounce back. We began the year with 108 clubs, but now only have 88 due to 5 being suspended. Paul congratulated the Club Coaches, Club Sponsors and Club Mentors for their work, but there are 49 clubs with 12 or fewer members that need a coach. As of today, we have 1,368 members in District 96. The District is also offering \$50 gift certificates to clubs that gain 5 new members between April 22 and June 30 and clubs that organize an Open House between April 22 and June 30. There are 4 clubs in the process of chartering (Red Leaf Raconteurs, Archiact Interactive Limited, Precision NanoSystems, and Provincial Health Services Authority).

Thanks were extended to all District 96 volunteers for their hard work.

14. PUBLIC RELATIONS MANAGER REPORT

Public Relations Manager, Charito Kaay, spoke about the results of a mystery shopper initiative, the impact of Facebook ads, and the need for a video editor on the PR team.

3.MOTIONS: All main motions shall be made in writing and signed by the maker and delivered to the Administration Manager before the meeting. Format for the motions is "I move that ..." or "Be it resolved that ..."

4. DECORUM: To avoid distractions during the meeting's business, please turn off all devices. Please, maintain courtesy when addressing the assembly. Please ensure that your device is on 'mute' unless you are speaking.

5. CONDUCT: Members wishing to speak, will use the 'raise hand' feature on Zoom and wait to be recognized by the chair, then state their name and club number before speaking.

6. DEBATE: Each voting member may speak twice for a maximum of two minutes on each debatable motion. Delegate may speak a second time after all who wish to speak have spoken once.
